His nomination was confirmed by the NC Senate and the NC House. On January 28, 2025, Governor Josh Stein reappointed him to fulfill the remainder of a previous Commissioner's term, which extends through June 30, 2029. Prior to his appointment to the NCUC, he served as a member of the North Carolina Senate for approximately 13 years,

where he served as the Senior Deputy Democratic Leader.

Commissioner McKissick is the son of the late civil rights leader and attorney, Floyd B. McKissick, Sr.

He received an A.B. Degree in Geography from Clark University in Worcester, Massachusetts; a master's degree in Regional Planning (MRP) from UNC-Chapel Hill, a master's degree in Public Administration (MPA) from Harvard University, and a Juris Doctor (J.D.)
